More Action Needed to Combat Fake Online Reviews, New Report Finds

WASHINGTON-Fraudulent online reviews, which deceive consumers and damage compani

es&#39; reputations, are a significant problem. While the public and private sec

tor have taken some steps to address the proliferation of fake reviews, a new re

port from the Center for Data Innovation concludes that state and federal govern

ments should strengthen their enforcement actions, partner with the private sect

or to develop best practices, and pass legislation to protect consumers from law

suits when they leave honest reviews.

The Center calls on policymakers to take four steps to address fake reviews:

The FTC and state attorneys general should combine their investigations and heig

hten enforcement actions against the actors pursuing or posting fraudulent revie

ws.

The FTC should work with review websites, e-commerce sites, and consumer brands

to develop best practices for preventing and detecting fake reviews.

The FTC should work with the private sector to create best practices for social

media companies to identify and remove fake reviews.

&quot;Fake reviews can deceive consumers and inaccurately reflect the quality of

businesses&#39; goods and services,&quot; said Stevens. &quot;To protect both c

onsumers and businesses, state and federal policymakers should work with the pri

ivate sector to identify and take enforcement actions against perpetrators of fak
